Applicants submitted an Area Variance for an addition of a screened porch and the extension deck. 1-story above grade at three-feet further towards the lake side lot line, then the existing deck inclusive of a 1-foot roof soffit overhang.

This application must go to the ZBA for a variance. In discussion regarding the Planning Board's opinion of this variance request, It was determined through discussion that this project is a self-created hardship and the following recommendation will be sent to the ZBA:

It is the Planning Board's opinion that this project is a **self-created hardship** and it is the Planning Board's recommendation that the Zoning Board of Appeals **DENY** this application for an Area Variance request for an addition of a screened porch and the extension deck of 1 story above grade at three feet further towards the lake side lot line. Then the existing deck inclusive of a one-foot roof soffit overhang.
