Code Revision- No transient Vendors in Town Parks

The board was presented two choice, they agreed on choice #1 as is:

LOCAL LAW NUMBER OF 2018

A Local Law Amending Section 76-12 of the Town Code

BE IT ENACTED by the Town Board of the Town of Urbana, New York as follows:

Section 1. Section 76-12(B) is hereby amended to read as follows:

76-12(B). Sell or offer for sale goods, wares, merchandise or food and beverages from any motorized vehicle or any other type of conveyance on any of the public streets and highways of the Town of Urbana and in Town parks except as hereinafter provided; provided, however, that the prohibition herein contained shall not include the bona fide delivery of goods, wares, merchandise or food and beverages made on a regular route to regular customers. With respect to Town parks, if the Town Board has approved an application for a special event to be held in a park and if the applicant discloses in its application its intention to have vendors sell or offer for sale goods, wares, merchandise or food and beverages from any motorized vehicle or any other type of conveyance, the sponsor of the event shall be solely responsible in determining which vendor(s) may participate in the event and shall verify that the vendor's vehicle or other type of conveyance meets all applicable vehicular laws and has all required department of health permits.

Section 2. This local law shall take effect upon adoption and upon filing with the New York State Secretary of State.

Attorney Ryan will write the law for the August Meeting using Section 1.

Dear Town Board,

John Webster has mentioned to me that the Town Board is requesting to allow any electrical inspector into the town and conduct business.

Electrical inspectors are an extension of my job responsibilities listed in the law and code books as "special inspections". Because there is <u>no</u> New York State certification for these people they work under my direction, paid by the project owner. With that being said I will continue to use the four inspectors that the former Code Official has chosen and used for the last twelve plus years and I have used for the last four years without incident.

With the complaints that came from the same two contractors that always seem to be the "victim" of having to follow the rules, I am considering at the first of the year, doing all my own electrical inspections to eliminate any controversy. Unfortunately this will mean all electrical inspections will have to be scheduled days if not weeks in advance and all liability will be placed on the Town. I will be approaching the board at a later date, prior to the first of the year during budget time , for an increase in pay to compensate the added work load and the Town's Fee Schedule will have to be adjusted to compensate fees generated by these inspections.
